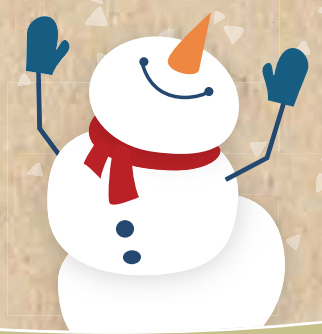

## MAC BEATON (INCUMBENT)

Mac has served as a member of the Henrico FCU Board of Directors since 2010. He has also been a member of the Asset Liability Management Committee, Associate Director/Director Emeritus Committee, Facilities Committee, and the Personnel Committee while on the board.



"I am committed to serving the members of the credit union. As a current board member, it is important to me to continue to look for ways to better serve our members while maintaining the core values that have made the credit union what it is today. I am also dedicated to helping continue with the mission of financial literacy education."

Mac is currently the Director of Career and Technical Education. He started his career as an Apprentice Electrician but has spent the last 31 years with Henrico County Schools as a teacher, Education Specialist, and for the last 17 years has served as the director.

## HENRY ROSENBAUM (INCUMBENT)

Henry Rosenbaum has served as a member of the Henrico Federal Credit Union Board of Directors since August 2015 and has been a credit union member since 1985. He is an active member of the community and previously volunteered with the Lakeside Volunteer Rescue Squad and the Virginia State Police Med-Flight program as a Paramedic.

Henry is currently the Fire Marshal for Henrico County Division of Fire. During his 32 years with Henrico Fire, Henry has advanced through the ranks of Battalion Chief. Henry served as the Resource Manager for four years where he managed facilities, apparatus, personnel and equipment budgets, as well as fire and EMS supplies and capital improvements.



"I will become well versed with all policies and laws of the credit union, the Federal Credit Union Act and all State and Federal Rules and Regulations pertaining to credit unions. I promise to uphold the responsibilities of a Board Member and advocate for Henrico Federal credit union members."

Voting Rules & Regulations: Nominations may also be made by petition, signed by a minimum of 1% of the members of Bellwood CU (maximum 500). Nominations by petition must be submitted to the secretary of the Board of Directors by February 17, 2017. The petition must be accompanied by a statement of qualifications, biographical data and a certificate, signed by the nominee that s/he is agreeable to nomination and will serve if elected. There will be no nominations from the floor at the Annual Meeting, unless at that time there are not sufficient nominees for the open Board positions. To be eligible to vote you must be a primary member of Bellwood CU and be at least 16 years of age.
