By signing above, you authorize Bellwood Credit Union to extend your final loan payment. Home equity loans are not eligible for Skip-A-Pay. The \$35 processing fee per loan will automatically be deducted from your Share/Savings and/or Checking Account. If the completed form is received at the West Broad Office no later than 5:00 pm on November 13, 2019 the processing fee will be \$30. Interest will continue to accumulate on your loan during the month you skip your payment. Payments made through Payroll Deduction or Direct Deposit will be deposited into your Share Savings Account for the month in which you are skipping a payment. Loans must be current at time of request. Loans may not be in a current modification, extension or workout program. New loans are eligible for Skip-a-pay after first payment has been received. Processing fee(s) must be available or Skip-A-Payment cannot be processed.
